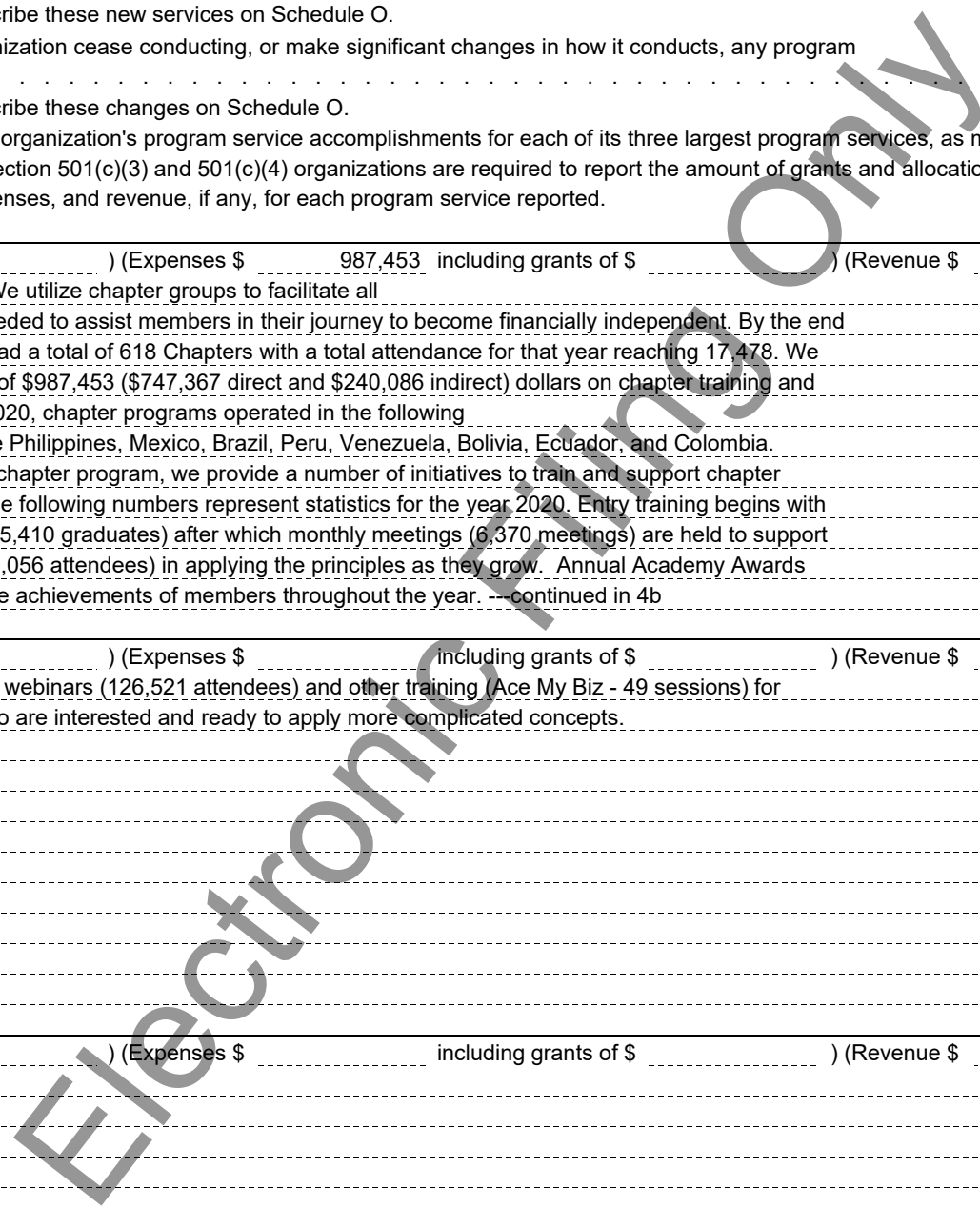

We utilize chapter groups to facilitate all programs needed to assist members in their journey to become financially independent. By the end of 2020 we had a total of 618 Chapters with a total attendance for that year reaching 17,478. We spent a total of \$987,453 (\$747,367 direct and \$240,086 indirect) dollars on chapter training and In the year 2020, chapter programs operated in the following countries: the Philippines, Mexico, Brazil, Peru, Venezuela, Bolivia, Ecuador, and Colombia. Through the chapter program, we provide a number of initiatives to train and support chapter members. The following numbers represent statistics for the year 2020. Entry training begins with Start Now! (15,410 graduates) after which monthly meetings (6,370 meetings) are held to support members (58,056 attendees) in applying the principles as they grow. Annual Academy Awards celebrates the achievements of members throughout the year. ---continued in 4b
