Grants were given to international programs who utilized member groups (called "Chapters") to facilitate all activity needed to assist members in their journey to become financially independent. By the end of 2024 a total of 1,109 Chapters were operating with a total training sessions for that year reaching 682 in which 23,190 students were trained. The Chapter trainings and support efforts helped participants form 10,165 new businesses (Income Earning Activities). Program expenditures totaled \$2,039,821 (\$1,459,876 direct and \$579,945 indirect) dollars on Chapter training and support, 81% of our annual budget.
